Sanitary Sewer Infrastructure Assessment in Piedras Negras, Coahuila

The local water utility, Sistema Municipal de Aguas y Saneamiento (SIMAS), in Piedras Negras, Coahuila, has received a grant from the North American Development Bank (NADBank) through its Project Development Assistance Program (PDAP), which operates with contributions from the U.S. Environmental Protection Agency (EPA), to perform a Sanitary Sewer Infrastructure Assessment in Piedras Negras, Coahuila.

SIMAS intends to hire a qualified consulting firm to develop the assessment.

Bidding for contracts financed by NADBank is open to firms from any country, subject to the conditions established in the NADBank Procurement Policies and Procedures. Because the funding for this project is administered by NADBank, the bid process will be carried out in accordance with its procurement policies and procedures and for anything not expressly indicated therein, with the Public Sector Procurement, Leases and Services Law. The consultant will be selected and contracted in accordance with NADBank Procurement Policies and Procedures.

As part of their proposal, bidders must submit a letter specifying that no individual or legal entity in their company has been previously penalized by NADBank or the Mexican Ministry of Government Services (*Secretaría de la Función Pública*) or had a contract cancelled by SIMAS.

Bids must be presented in Mexican pesos.

No advance payment will be provided.

Pre-award expenses incurred by the bidders in collecting preliminary information, preparing the proposal and negotiating the contract are not reimbursable.

The general criteria for contract award will be based on points and percentages.

Payments will be made based on invoices for work performed, which must be submitted no more than once a month.

This procurement process is not covered under any treaty.
