Wastewater Collection System (Phase I) and Lift Station Improvements in Mexicali, Baja California, Mexico

The local water utility, *Comisión Estatal de Servicios Públicos de Mexicali* (CESPM or the Executing Agency), has received a grant from the North American Development Bank (NADB) through its the Border Environment Infrastructure Fund (BEIF), which is funded by the U.S. Environmental Protection Agency (EPA), as authorized in Grant Agreement BEIF BC9300, to finance part of the costs associated with the project for Wastewater Collection System (Phase I) and Lift Station Improvements in Mexicali, Baja California (the "Project").

CESPM intends to contract two consulting firms to carry out the following services:

Management, coordination, and supervision services for the replacement of 2,972 linear meters of concrete sanitary sewer lines at the subdivisions of Nueva (432 meters), Baja California (484 meters), Pueblo Nuevo (1,036 meters) and Libertad (1,020 meters), in Mexicali, Baja California.

Management, coordination, and supervision services for the replacement of 2,266 linear meters of concrete sanitary sewer lines at the subdivisions of Primera Sección (298 meters), Bordo Wisteria (348 meters), Industrial (1,257 meters) and Las Flores (363 meters), in Mexicali, Baja California.

The project consists of the replacement of 2,972 and 2,266 linear meters of concrete sewer lines using 8-inch, 10-inch, 12-inch, 15-inch, and 18-inch diameter PVC pipes, that meet ASTM D-3034 SDR-35 and ASTM F-679-08 SDR-35 specifications. The services will consist of verifying that construction work is carried out in accordance with the designs, specifications, and established standards, as well as monitoring project performance and the use of funds provided by NADB.

Bidding for contracts financed by NADB is open to firms from any country. Because the funding for this project is administered by NADB, the bidding process will be carried out in accordance with its procurement policies. Companies that have been previously penalized by NADB and/or had contracts cancelled by CESPM are not eligible to participate in the bidding process.

Qualified interested companies are hereby invited to submit technical and financial bids in Spanish in a sealed envelope, for a work order fixed-term contract to carry out the aforesaid services.

Bids may be presented in U.S. dollars or Mexican pesos. Monthly invoices will be paid in the currency indicated in the bid. For the purposes of evaluation only, the exchange rate published in the *Diario Oficial de la Federación* for the settling of

obligations denominated in foreign currency payable in Mexico, will be used. The date used as the basis for the conversion will be six calendar days prior to the date for opening the bids.

No advance payment will be provided for the execution of this contract.

Project implementation for both contracts will take approximately 152 calendar days. The probable start-up date for the works is November 15, 2021, and the completion date is April 15, 2021, respectively.

Bid documents will be made available via Internet at <u>www.Compranet.gob.mx</u>; however, the general requirements that will be requested in the bid documents and that must be covered in the bid are as follows:

- 1. Brief description of the company, its organization, and services.
- 2. Companies interested in providing the services must have at least five years of experience in supervising construction works of a comparable complexity and similar or greater size.
- 3. Details concerning the experience required for the work advertised, gained over the last 5 years, including a brief description of the activities performed, amount contracted, duration of the work and the personnel who participated.
- 4. Contact name and phone number for at least three projects completed within the past five years, as references.
- 5. Curriculum vitae of staff available to work on this project. Consideration will only be given to the CVs of those persons that have direct experience in water and wastewater infrastructure projects and who have the ability to work in Spanish.

Bidders are encouraged to visit and inspect the work sites and surrounding area and obtain for themselves and at their own responsibility all the information that may be needed to prepare their bids and execute the service contract.

CESPM will hold a **pre-bid meeting** on Tuesday, **September 28, 2021**, at **10:00** a.m. and **12:00** pm (local time), respectively, at the offices of Administration and Finances in the Procurement Department, located at: Calle Río Sinaloa No. 1399, Col. Vallarta, C.P. 21270, Mexicali, Baja California, Mexico.

All questions from potential bidders must be submitted in writing on Monday, September 27, 2021, no later than 10:00 am and 12:00 pm (local time), respectively, to the attention of the General Manager of the Executing Agency indicated below. The responses to the questions will be provided as a minute of the pre-bid meeting or a Clarification addendum to the procurement documents, as necessary, and will be published on the Internet at https://compranet.hacienda.gob.mx.

Bidders must submit separate technical and financial proposals in accordance with the instructions provided by the Executing Agency. Bidders must not include any type of pricing information in the technical proposal. Proposals must be valid for a period of ninety (90) days from the date of submission, during which the proposed price and personnel shall not be changed.
