Wastewater Lateral Connections to the International Outfall Interceptor (IOI)
in Nogales, Arizona

The City of Nogales, Arizona (the "Owner") request bids for construction of the Wastewater Lateral Connections to the International Outfall Interceptor (IOI) Project (the "Project"). The IOI serves the cities of Nogales, Arizona and Nogales, Sonora, Mexico and conveys wastewater to the Nogales International Wastewater Treatment Plant (NIWTP). The proposed project consists of:

- Relocating and/or abandoning sewer laterals at FIVE (5) sites within the city of Nogales, Arizona, identified as sites 1, 4, 5, 7, and 8. Three of these sites, identified as 1, 4, and 5 will be prioritized to be completed first.
- Install approx. 823 ft of 8" dia. PVC SDR-35 pipe.

The Project is being partially financed by the North American Development Bank (NADB), through its Border Environment Infrastructure Fund Program (BEIF) which is funded by the U.S. Environmental Protection Agency (EPA). EPA-funded or assisted projects must comply with the Civil Rights Act, Equal Employment Opportunity requirements, and promote Small, Minority and Women-owned Businesses participation through EPA's Disadvantaged Business Enterprise (DBE) Program. Bidding for contracts to be financed with the proceeds of a NADB grant are open to firms from any eligible country, and will accept bids from qualified firms registered with the Arizona Registrar of Contractors.

The bid process will be carried out in accordance with NADB's procurement policies and procedures. Companies that have been previously penalized by NADB and/or by the City of Nogales, Arizona are not eligible. Contractors/subcontractors that have been debarred, suspended or otherwise excluded from or are ineligible for participation in federal assistance programs may not undertake any activity in part or in full under this project.

A **mandatory** pre-bid conference and site inspection will be conducted **October 12, 2021 at 9:00 a.m (Arizona local Time)** at the Nogales Public Works Department, 1450 N Hohokam Dr., Nogales, Arizona 85621.

Sealed bids will be received at the Nogales City Hall, 777 N Grand Ave Nogales, Arizona 85621, Attn: City Clerk, Leticia Robinson **until 4 p.m.** (Arizona local time), on **October 21, 2021**.

No bid will be accepted unless it is made on the Bidder's Proposal Forms furnished by the City. All bids are to be compared to the Engineer's estimate of quantities of work to be done. The City reserves the right to reject any and all bids or any part thereof, or to accept any bids or any part thereof, or to waive any irregularity, informality, or technicality in any bid, or to withhold the award to the extent permitted by law. The City further reserves the right to seek new bids if, in their judgment, the best interest of the City will be promoted thereby. The Bidder may not withdraw his/her bid prior to execution of the contract by the successful bidder. In accordance with the provisions of Chapter 10, Title 32, entitled "Professions and Occupations" of the Arizona Revised Statutes, no bid will be accepted from a bidder who is not fully and properly licensed as a contractor for the work to be done by him/her.

Each bid shall be made out on the Bid Proposal Form and shall be accompanied by a Bid Bond for a sum of not less than ten percent (10%) of the amount of the bid as requested within the Instructions to Bidders.

Failure to execute the Contract Agreement and/or submit the required Insurance Certificates to the City within ten (10) calendar days after the date of the award of the Contract may be just cause for the annulment of the award. No work shall be started until the Contractor has obtained all necessary permits related to this Project. The Contractor shall obtain and pay for all permits and fees and give all notices incidental to the due and lawful prosecution of the work and to the preservation of the public health and safety.
