The local water utility, *Comisión Estatal de Servicios Públicos de Mexicali* (CESPM or the Executing Agency), has received grant funding pursuant to Grant Agreement **BEIF BC1010** from the North American Development Bank (NADBank) through its Border Environment Infrastructure Fund (BEIF), which is funded by contributions from the U.S. Environmental Protection Agency (EPA), to finance part of the costs associated with the Small Lift Station Rehabilitation Project in Mexicali, Baja California" (the "Project").

CESPM plans to contract a consulting firm to provide the following services:

Companies that have been previously penalized by NADBank and/or had contracts cancelled by CESPM are not eligible to participate in the bidding process.

Qualified interested companies are hereby invited to submit technical and financial bids in Spanish in a sealed envelope, for a fixed-term contract, on a work order basis, to carry out the aforesaid services.

Bids may be presented in U.S. dollars or Mexican pesos. Monthly invoices will be paid in the currency indicated in the bid. For the purposes of bid evaluation only, the exchange rate published in the *Diario Oficial de la Federación* for the settling of obligations denominated in foreign currency payable in Mexico, will be used. The date used as the basis for the conversion will be six calendar days prior to the date for opening the bids.

No advance payment for these services will be provided.

The duration of this work is approximately 170 calendar days. The probable start-up and completion dates for the work are **July 12, 2022** and **May 7, 2023**, respectively

Bid documents will be obtained via the Internet at https://compranet.hacienda.gob.mx; however, the general requirements outlined in the bid documents that bidders must meet are as follows:

- 1. Brief description of the company, its organization and services.
- 2. Companies interested in providing the services must have at least five years of experience in supervising construction works of a comparable complexity and similar or greater size.
- 3. Details concerning the experience required for the work advertised, gained over the last five years, including a brief description of the activities performed, amount contracted, duration of the work and the personnel who participated.
- 4. Contact name and phone number for at least three references for projects completed within the past five years.
- 5. Curriculum vitae of staff available to work on this project. Consideration will only be given to the CVs of those persons that have direct experience in water and wastewater infrastructure and electrical, control and mechanical works and who have the ability to work in Spanish.

Bidders are encouraged to visit and inspect the work sites and surrounding area on their own to obtain all the information that may be needed to prepare their bids and execute the service contract.

Bidders must submit separate technical and financial proposals in accordance with the instructions provided by the Executing Agency. Bidders must not include any type of pricing information in the technical proposal. Proposals must be valid for a period of ninety (90) days from the date of submission, during which the proposed price and personnel for the project shall not be changed.
